### **Emergency Overview**

Physical Description & Colour: Circular, pink tablets with convex sides.

The SWA TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. ### **Section 4 - First Aid Measures**

#### **General Information:**

## **Section 6 - Accidental Release Measures**

**Accidental release:** This product is sold in small packages, and the accidental release from one of these is not usually a cause for concern. ## SWA Exposure Limits TWA (mg/m³) STEL (mg/m³)

Exposure limits have not been established by SWA for any of the significant ingredients in this product.

The ADI for Amoxycyllin is set at 0.2mg/kg/day. The corresponding NOEL is set at 200mg/kg/day.

The ADI for Clavulanic acid is set at 0.01mg/kg/day. The corresponding NOEL is set at 10mg/kg/day. ADI means Acceptable Daily Intake; NOEL means No-observable-effect-level. Taken from Australian ADI List, June 2014.

No special equipment is usually needed when occasionally handling small quantities. The following instructions are for bulk handling or where regular exposure in an occupational setting occurs without proper containment systems.
