Section 8 - Exposure Controls and Personal Protection

Occupational exposure limits:

TWA (mg/m³) SWA Exposure Limits Exposure limits have not been established for any of the significant ingredients in this product.

The ADI for Flunixin meglumine is set at 0.006mg/kg/day. The corresponding NOEL is set at 0.6mg/kg/day. ADI means Acceptable Daily Intake; NOEL means No-observable-effect-level. Data from Australian ADI List, June 2014.

The SWA TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that may be equalled (but should not be exceeded) for no longer than 15 minutes and should not be repeated more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak "is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.
