#### **General Information:**

Exposure limits have not been established by SWA for any of the significant ingredients in this product.

The ADI for Amoxycyllin is set at 0.2mg/kg/day. The corresponding NOEL is set at 200mg/kg/day.

The ADI for Clavulanic acid is set at 0.01mg/kg/day. The corresponding NOEL is set at 10mg/kg/day. ADI means Acceptable Daily Intake; NOEL means No-observable-effect-level. Taken from Australian ADI List, June 2014.
